

**Coronado Title I Parent Engagement Plan**

**PART I. General Expectations**

Coronado agrees to implement the following statutory requirements:

- Consistent with section 1118, the school will work to ensure that the required campus Title I Parent Engagement Plan meet the requirements of section 1118(b) of the ESEA, and include as a component, a school-parent compact consistent with section 1118(d) of the ESEA.

E. the carrying out of other activities, such as those described in section 1118 of the ESEA.

**PART II.** Description of how Coronado will implement the required components of the campus Title I Parent Engagement Plan.

1. Coronado will take the following actions to involve parents in the joint development of its campus Parent Engagement Plan under section 1112 of the ESEA:

- Establish the campus Parent Engagement Advisory Council adequately represented by parents of attending children, administrators and Title I personnel. Other council members may include community members and students.
- Annually hold a meeting to review, discuss, and revise the school's Title I Parent Engagement Plan.
  - Parents will be invited to participate in the Title I Engagement Plan by participating in an online Google Survey. All parents will receive the link and be given the opportunity to provide input.

2. Coronado will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:

- Hold committee meetings, composed of parents and school staff, to review the Campus Improvement Plan.
  - Parents will be invited to participate in the Title I Engagement Plan by participating in an online Google Survey. All parents will receive the link and be given the opportunity to provide input.
- Provide Title I, Part A school staff support in enhancing their School Campus Improvement Plans.
  - Staff training will take place during staff development on campus and inter-district.
- Administer the Title I campus Parent Engagement Survey designed to identify the type of support, information, and resources that parents' need included in their Campus Improvement Plan and campus Parent Engagement Plan to better support their children's education and become more involved in their school.

3. Coronado will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in the Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting and will encourage them to attend. These informative meetings may include, but are not limited to, the following:

- Registration, Burger Bash, Fall Dance, Spring Fling, etc.

4. Coronado will, in a timely manner, provide parents of participating children information about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet:

- The information may be provided through a Student Expectations Brochure, Parent conferences, STAAR night, or other special meetings.

5. Coronado will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible. These may include, but are not limited to, the following:

- Suggestion box, parental involvement meetings, Parenting Partners program, etc.

6. Coronado will provide each parent an individualized student report regarding the performance of their child on the state assessment in at least math, language arts and reading by:

- Ensuring each parent has Skyward Family Access to access their student's scores. Phone messages, Facebook reminders, and Remind 101 messages will let parents know when these scores are available.

7. Coronado will provide assistance to parents of children served by the school, as appropriate, on important topics. These may include, but are not limited to, the following:

- Reviewing and understanding the state's academic content standards
- Reviewing and understanding the state's student academic achievement standards
- Reviewing and understanding the state and local academic assessments including alternative assessments
- The requirements of Title I, Part A
- How to monitor their child's academic progress
- How to work with educators
- Other topics that received strong parent interest as reflected by the Title I school Parent Engagement Survey

8. Coronado will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parent engagement. These may include, but are not limited to, the following:

- Library Night/Literacy Night
- Math Night
- Science Night
- Discovery Center Night
- Skyward Parent Training
- Parenting Partners
- Lunch and Learn

9. Coronado will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools. These efforts may include, but are not limited to, the following:

- Parent Panels
- Parenting Partners
- Lunch and Learn

10. Coronado will, to the extent feasible and appropriate, coordinate and integrate TI parental engagement programs and activities with public preschool and other similar programs (e.g., Head Start, Parents as Teachers, etc.) that encourage and support parents in more fully participating in the education of their children. These efforts may include, but are not limited to, the following:

- Preschool Parent Meeting
- Kindergarten Parent Meeting
- Parenting Partners

11. Coronado will take the following actions to ensure that information related to the school, parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand. These may include, but are not limited to, the following:

- Use of interpreter to communicate with parents and staff
- Letters in home language

### **PART III. Discretionary Components of the Coronado Title I Parent Engagement Plan**
